Fund Manager Comment

As per World Bank,

“Energy prices gained 6.4% in June, led by crude oil (6.1%) and European natural gas (15.1%). Non-energy prices fell 4%. Agricultural prices dropped 3.7%. Food prices declined 4.7%, led by grains (-6.6%) and oils & meals (-5.7%). Beverages gained 1.7% while raw materials fell 2.3%. Fertilizer prices eased 0.9%. Metal prices plunged 5.5%, with some key metals registering sizeable declines (e.g., tin dropped 11.8%, aluminium 9.4%, and nickel 8.6%). Precious metal prices eased 0.8%.”

“In 2021, some commodity prices rose to or exceeded levels not seen since the spike of 2011. For example, natural gas and coal prices reached record highs amid supply constraints and rebounding demand for electricity, although they are expected to decline in 2022 as demand eases and supply improves. However, additional price spikes may occur in the nearterm amid very low inventories and persistent supply bottlenecks.

Crude oil prices (an average of Brent, WTI, and Dubai) are expected to average \$70 in 2021, an increase of 70 percent. They are projected to be \$74 a barrel in 2022 as oil demand strengthens and reaches pre-pandemic levels. The use of crude oil as a substitute for natural gas presents a major upside risk to the demand outlook, although higher energy prices may start to weigh on global growth.

As global growth softens and supply disruptions are resolved, metal prices are forecast to fall 5 percent in 2022, after rising by an estimated 48 percent in 2021. Following a projected 22 percent increase in 2021, agricultural prices are expected to decline modestly next year as supply conditions improve and energy prices stabilize.”
